#### **Position Concept**

JA Finance Park® is an innovative experiential learning experience designed to prepare students for life and work in the real world. Middle and high school students learn and practice how to make informed decisions for lifelong success by aligning the realities of life. Students learn how personal choices affect financial stability, how education drives career decisions, and their income expectations. Students experience first-hand what it takes to make it in the JA Finance Park® budgeting simulation.

JA Finance Park® serves approximately 11,000 students annually and engages 2,000 adult volunteers each year to guide students through our budgeting simulation. This position oversees the facility-based program operations, execution of JA Finance Park® learning experience, and serves as the onsite lead for the facility's safety and security which includes constituents, staff, students, volunteers, teachers, and guests.

The JA Finance Park® Manager is a member of the Education team. As a manager, you will be supporting facility-based learning experiences to students across the region and ensuring constituents are supported, prepared and motivated when delivering financial literacy to middle and high school students. In this role, you will report to the Senior Director, Capstone Experiences, and will help to support the regional and national sharing of best practices, the fidelity of programs and operations across the region. This position manages a team of part-time associates who execute the daily operation of the JA Finance Park® simulation.

# **Primary Responsibilities**

- Manages the JA Finance Park® facility and simulation
- Provides exceptional management of operations within the JA Finance Park® facility to include supervising and training of JA Finance Park® associates.
- Stewards any constituents who visit JA Finance Park® including, but are not limited to, corporate, community and family volunteers, school staff, and students.
- Serves as simulation software lead, conducting improvements and updates, ensuring daily readiness and interfacing with Junior Achievement's national arm, JA USA.
- Assures program quality through daily engagement in the simulation.
- Provides feedback to help maintain program fidelity.
- Creates and manages staffing calendar and work plans.
- Conducts weekly briefings with part time associates.
- Ensures effective delivery of all daily trainings.

Cross-trains in all facility roles and maintains connectedness to daily simulation by taking on peer roles
within the facility on a scheduled basis including serving as a volunteer and conducting teacher training.
